



Report Shows Legislature Votes Pro-Growth

OKLAHOMA CITY (Aug. 24, 2023) – With fewer pieces of anti-growth legislation than in years past and over 40 perfect scores, the results of this year’s RIED Report point toward a business-friendly legislative session.

The State Chamber is encouraged by the pro-growth voting among our state’s senators and representatives. Forty-five lawmakers had a perfect score of supporting bills that will lead to a business-friendly environment for Oklahoma companies.

“You can’t make progress if you are not measuring the success of your efforts. For 25 years, RIED has offered a great way to track the pro-business sentiment of our legislature,” said Chad Warmington, president and CEO of The State Chamber of Oklahoma. “It’s a tool that we value and rely on to make sure elected officials are supporting pro-business issues at the State Capitol.”

RIED (Research Institute for Economic Development) creates a profile of each legislator’s individual voting record on bills impacting business, industry, job creation, and economic growth issues deemed important by the private sector. Each legislator is graded with respect to his or her vote on each bill.
